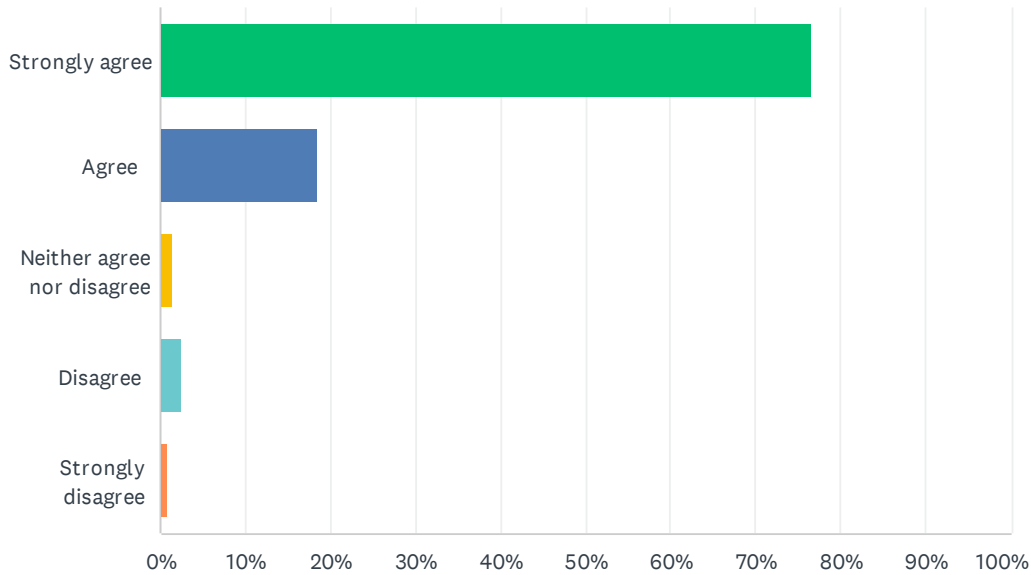

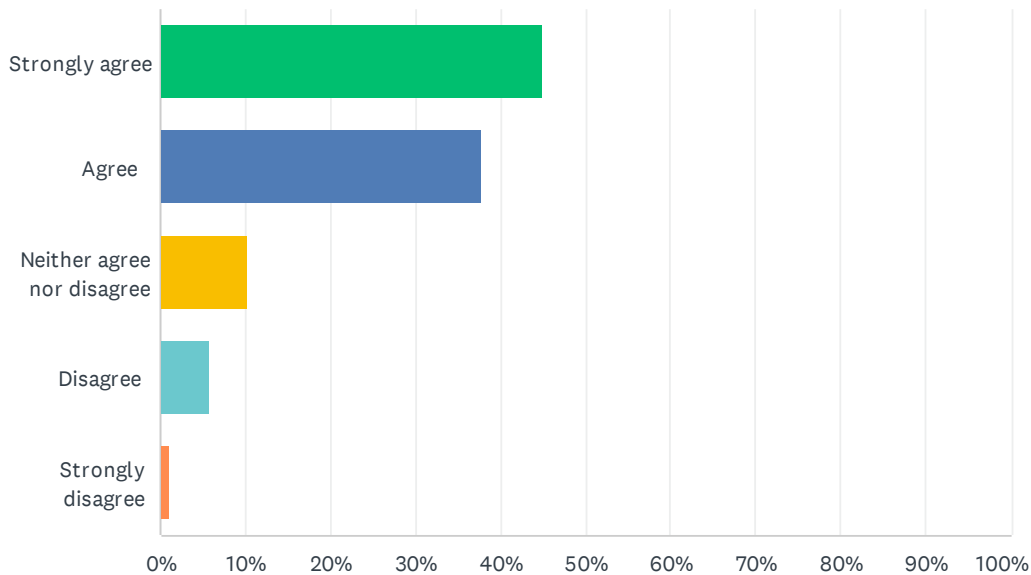

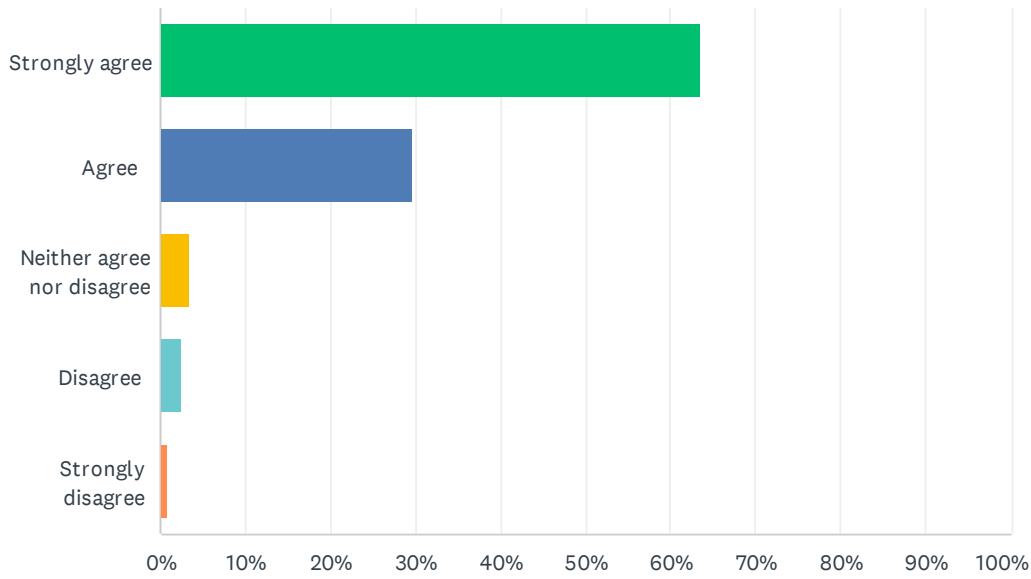

### Q3 IREF to operate a system of advocacy to help clubs comply with rules, but also have strong investigatory and enforcement powers.

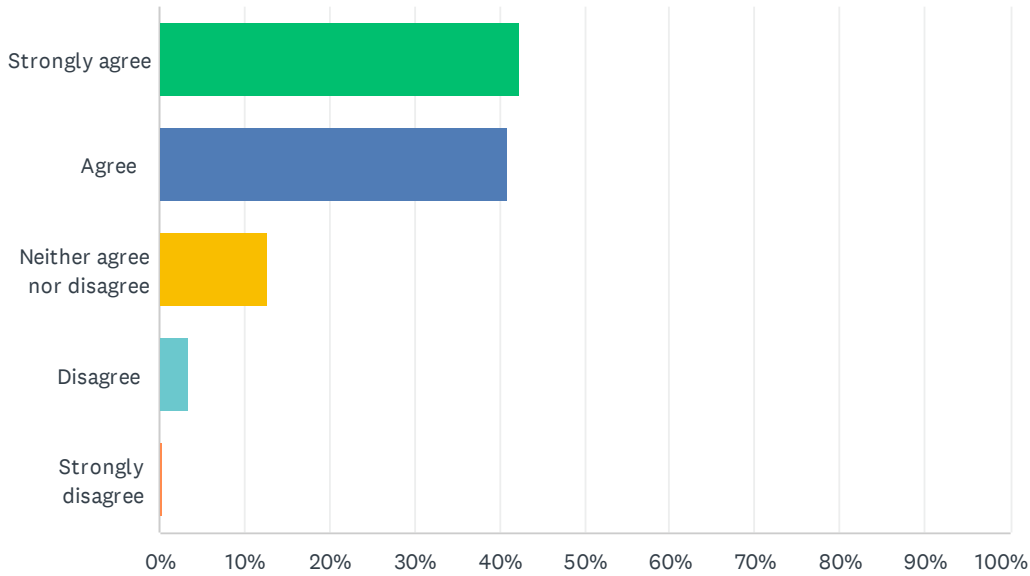

Q4 IREF should have a chair and board with expertise from a range of industries, appointed by a panel of experts separate from the government. The FA should have observer status on the IREF board.

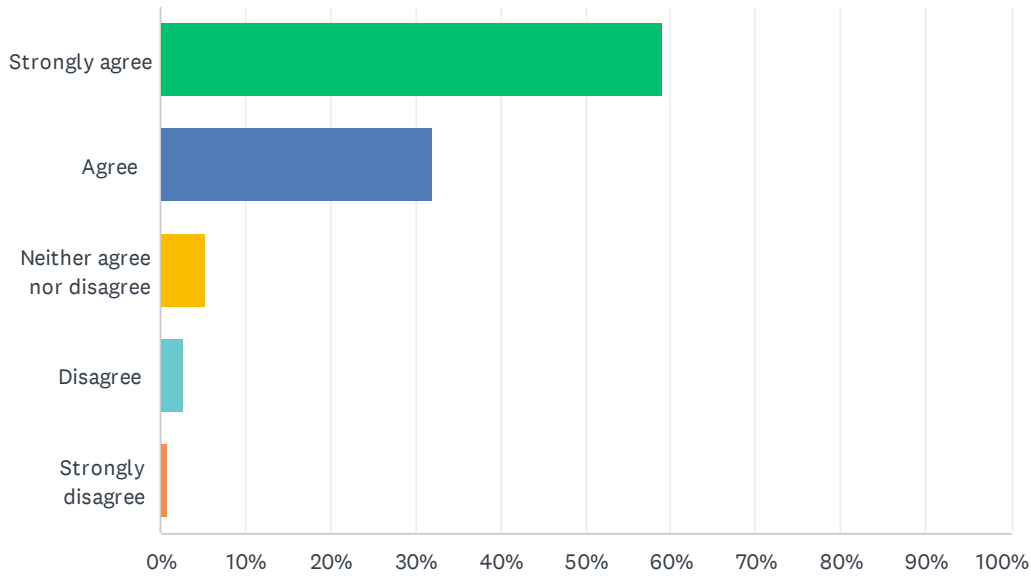

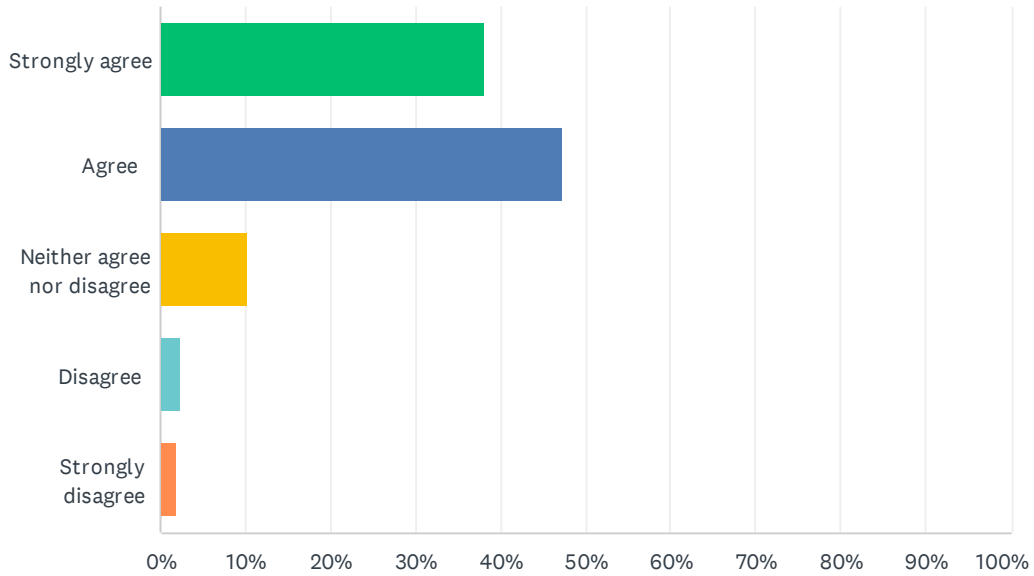
