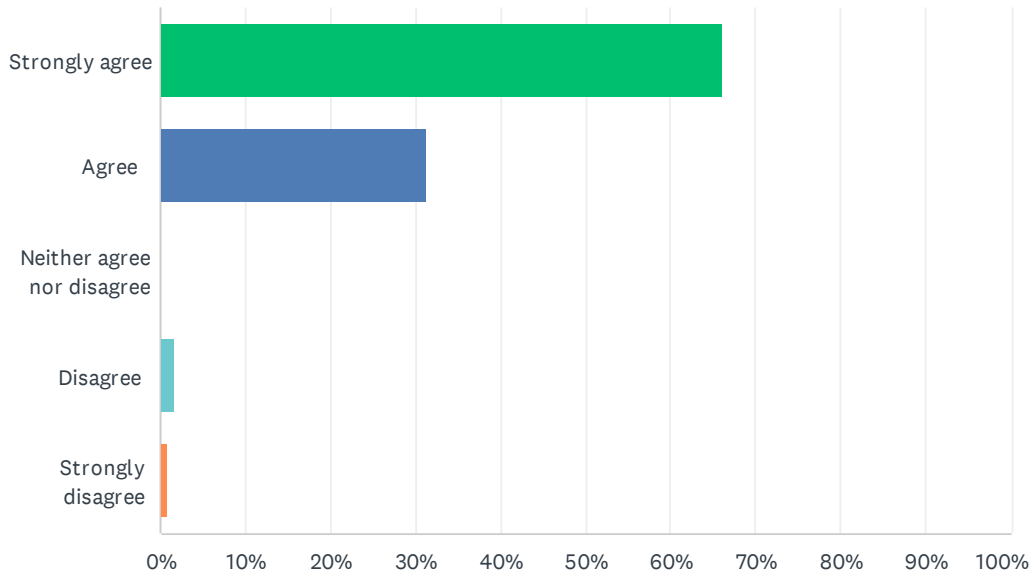

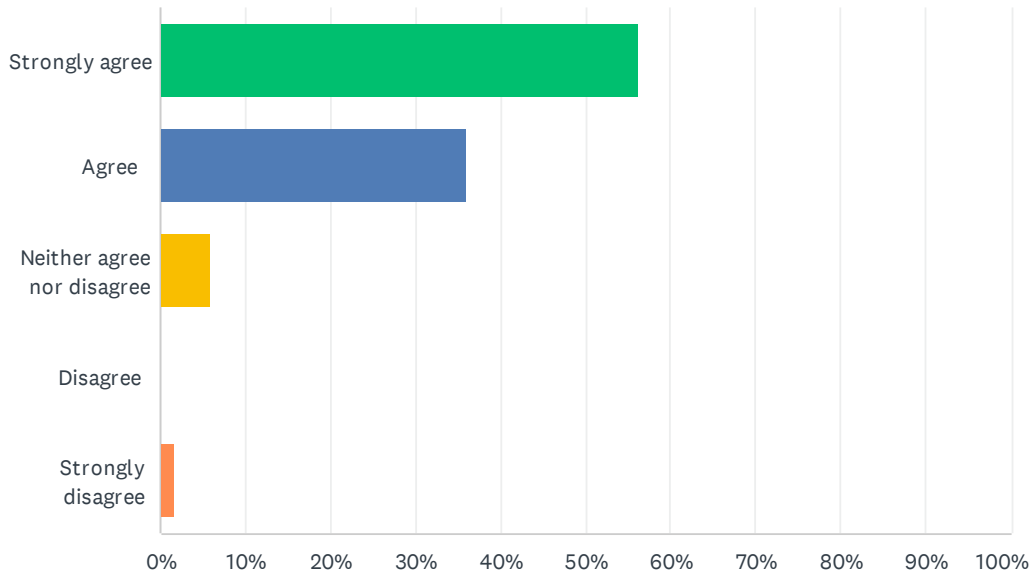

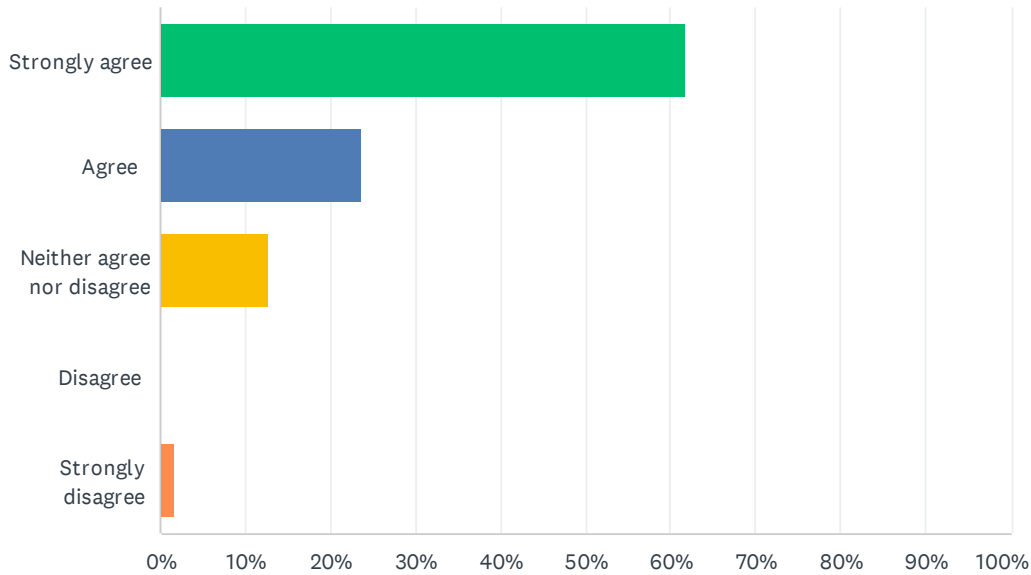

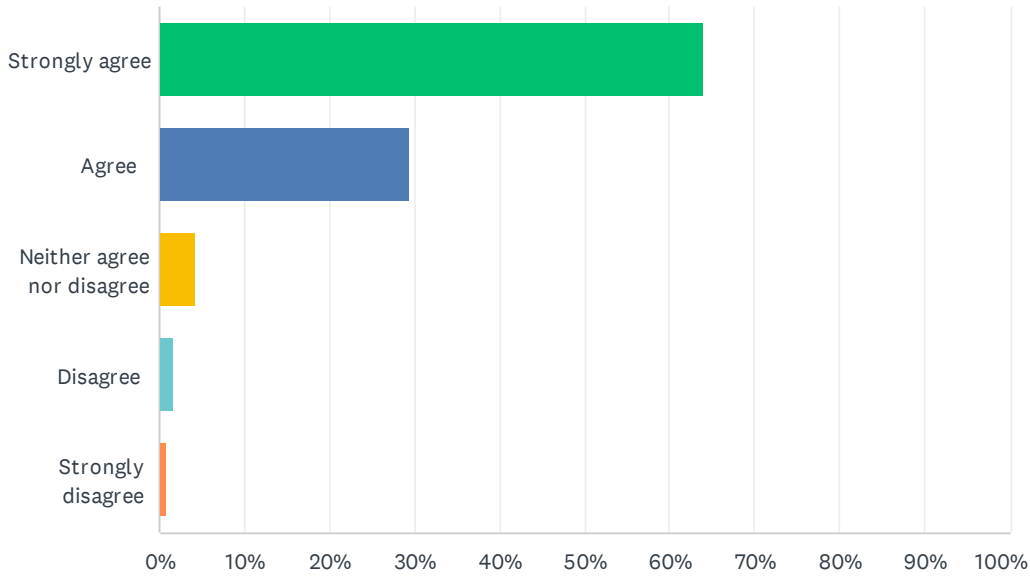

Q8 35. The government should explore the viability of introducing new security of tenure property rights for clubs where the club does not own the stadium in which it plays.

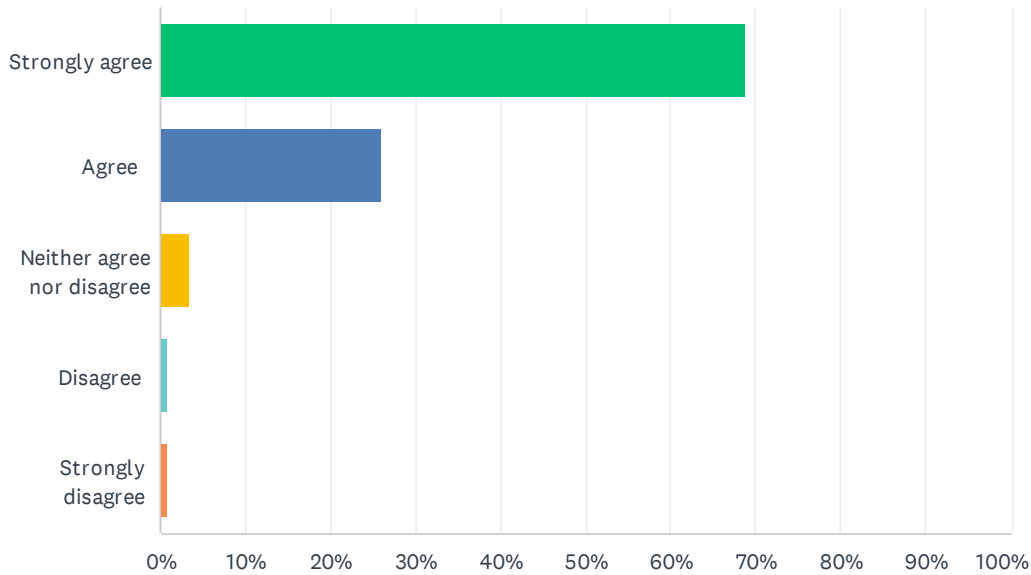
